1. Interested party/ transporter may apply their quoted rate in a sealed envelope latest by 23/03/2024 during office hours. We require buses not before 2015 model

2. Buses should be fully covered under Govt. norms laid by the transport department and vehicle on the road shall at all times carry the following valid documents (in original) and shall be produced on demand by officer empowered to demand documents by or under the motor vehicle Act 1988 along with documents shown in e parivahan portal whenever required:

- Certificate of Registration.
- Certificate of Fitness,
- Certificate of Insurance,
- Taxation Certificate (Tax Token)
- Driving License with badge,
- Permit granted by the Regional Transport Authority.
- Pollution Under Control certificate upto date papers required for smooth and hassle free work in the school.

3. Hire charges will be paid to transporter by account payee cheque only after deducting TDS as per Income-tax rule, Govt. of India.

4. Transporters will be responsible to deduct PF and ESIC contribution of the drivers and khalasi and also liable to police & road accident litigation etc.

5. Reimbursement of diesel will be provided by the school management as per the running average mentioned in the agreement.

6. In case, the bus breaks - down, the transporter will make alternative arrangement at his own level.

7. Agreement will be applicable for 12 months w.e.f is 01.04.2024 to 31.03.2025

8. All the buses must have Bio-matric system, First-aid box, GPRS & CC camera installed.

9. Employees must be appointed as per the guide lines framed by the Govt. of Jharkhand state employment of local candidate in private sector rules 2022.
